Community Development



EDUCATION | COMPAS - YOUTH FOR THE FUTURE

According to a 2017 educational study conducted by Fundación Punta de Mita in Corral del Risco, Emiliano Zapata and Higuera Blanca, these are the first generations to study beyond middle school.

COMPAS is a program designed to promote the completion of high school for teenagers in our local high schools. The program structure and activities are based on research showing that strong interpersonal relationships and networks, increased self esteem, and family support are vital in students' motivation, and therefore in the reduction of drop-out rates. 2018 marked the first full year of the COMPAS program. We are grateful to the Bronfman Family Fund who sponsored 8 COMPAS students in its first year.

What our COMPAS students say about the program:

"COMPAS has helped me to"...

- ... better balance obligations at school and at home
- ... improve the quality of conversations at home
- ... learn specific steps I need to take to get to where I want to be
- ...relieve some of the stress related to basic school and family needs.

The COMPAS program includes:

• 18 personal development workshops for 57 high school students

- 2-day leadership retreat
- · Books, uniforms, schools supplies, transportation
- 1 local university visit
- 40 hours of one-on-one guidance
- 25 hours of one-on-one guidance for parents
- 6 savings accounts opened by COMPAS students.

While students and families appreciate the economic support, it is the improvement of family dynamics, the creation of new friendships, improved self worth, and the realization that they are in control of the decisions that shape their futures, which truly make a difference in students' commitment to continuing their education.

EDUCATION | PUBLIC SCHOOL SUPPORT

2018 was our first year to consolidate FPM's work with public schools into grantmaking so that all of the 11 schools in Nuevo Corral del Risco, Emiliano Zapata and Higuera Blanca have equal opportunities for support. This year our grants focused on **maintenance and infrastructure needs** and we had 4 applications, of which 3 schools applied for grants. The advantage of working with the schools this way is that we are able to coach the Parent Associations and principals through project development and budget writing, and because this is a matching grant, the money they raise in their school events is matched by the Foundation.

Promotion of Sports and health activities


Fundación Punta de Mita has partnered with the city of Bahía de Banderas for the past several years as administrator of the Punta de Mita Sports Center. Annual maintenance in 2018 was \$304,899 MXN and we are very grateful to the **Bronfman Family Fund** for providing the \$721,000 MXN needed for construction of the beautiful concrete bleachers, which include long-needed shaded area and storage space/dressing rooms.

There are currently **8 soccer teams** that practice at the Sports Center with volunteer coaches. In In addition, our local elementary school teacher Ezequiel, trains 21 children in **Taekwondo** and Susy continues giving **Zumba classes in the mornings.**

The girl's soccer team, coached by Mauricio and Blas, were sponsored through FPM by **Connell & Associates** this year and came in second place at the "Liga Femenil" tournament in Bahía de Banderas.

HEALTH | HEALTH IN YOUR HANDS

2018 was the second of a two-year grant period for our program "La Salud en Tus Manos" (Health in your Hands), with a total project cost of \$75,600 US. This year was focused on two areas of family-centered health - children through the age of 6 and adolescents. In partnership with Johns Hopkins University professor and founder of the Child and Adolescent Health Measurement Initiative (CAHMI) Christina Bethell, as well as the University of Guadalajara / CUC campus and the Bahía de Banderas Health department, we were able to provide training to 3 community health leaders, introduce 44 families to an online tool with age-specific questions about child health, advocate for the proper manning of our two public health centers, and collect invaluable information about concerns and attitudes about health among families.

Health concerns that our participants shared:

Parents of children 6 and under

- 44% had questions about how to raise their children
- 23% had concerns about how to keep their child safe
- 50% said they sometimes have trouble covering basic monthly costs, including food
- 50% said they felt there is excessive drinking in their home

Teenagers ages 13 to 18

- Weight issues
- Anger management
- Sleeping issues
- Headaches
- Self-esteem
- Stomach-aches

ENVIRONMENT | ECO-MITA

Alliances and Environmental Education - As in all the pillars of FPM, we believe that alliances and collaborative work are crucial for the sustainable success of a program. Particularly in the topic of the Environment, where we are seeing changes

resources and promote environmental awareness in our population. We do this in three main ways:

in the consciousness and behavior of a large number of people in a geographically wide area, these collaborations are essential for the impact we can have. As such, FPM is part of a network of non-profit organizations that organize environmental education activities throughout the Bay, and we continue to be part of the advisory committee of Islas Marietas National Park.

Eco-Mita is an integral program undertaken by FPM since 2017 to increase our impact on the conservation of our natural

Grants - This year the first EcoMita grant was delivered, this is aimed at the social dimension of environmental conservation, awareness, etc. The selected project was the San Pancho Bird Observatory: more than 40 hours of practical workshops and field learning to develop, validate and professionalize the interpretation skills of 12 local guides and promote sustainable ecological tourism in the region.

Integrate environmental awareness, recycling, and waste reduction in the Del Mar Community Center and FPM activities

In el Centro Comunitario del Mar we reuse more than 150 glasses and plates for daily use and in events, and we also have a recycling station from "Mita Recicla" project.

Thanks to an amazing amount of volunteers, we were able to offer over 30 workshops for children and adults from our communities, some on a weekly basis and some for a one-day or limited week course. The core values that are promoted at Del Mar are Inclusion, Responsibility, Respect and Volunteerism and we are happy to see so many new people arrive each week.

We are also thrilled to have so many "walk-ins" at the community center. Visitors and local residents have contributed by donating their time, talent and treasures to making this community more integrated.

COMMUNITY DEVELOPMENT | REGIONAL SUPPORT

Fundación Punta de Mita is very dedicated to the **strengthening of other nonprofits and grassroots groups.** By fortifying these groups we can help them increase the effectiveness of their work and, in turn, the benefit to the communities of the entire bay.

14th Annual International Altruism Festival

This marks our second year working on the organization committee of the International Altruism Festival (FIA). For the first time in its 14 years operating, the FIA broke the One Million pesos fundraising mark! Besides being a much-needed source of funding for these organizations, it is an excellent learning opportunity for them, whether it be on volunteer management, large event organization, or an chance to approach new donors and media organizations.

Pro-Mita

2018 marks the 2nd year of the Pro-Mita Grant, which is raised through the Charity Golf Classic. The purpose of this grant is to support community priorities in Emiliano Zapata, Corral del Risco, and Higuera Blanca. It is also a mechanism by which we can develop a sense of agency and community capacities for **designing and implementing projects** to bring about the changes they would like to see in their towns.

This year, the project chosen was executed by The Jay Sadler Project. They partnered with an El Anclote resident's group to replace the Corral del Risco Preschool playground equipment, which had begun rotting away, and to fix some long-standing plumbing issues so that the children would have running water in their bathrooms.

FOROB GRANTS STRENGTHENING GRASSROOTS ORGANIZATIONS

This was our 3rd year offering the FOROB grant, which seeks to strengthen other non profits' capabilities through two main mechanisms: **mobilization of funds and mentoring:** First, the grant project itself should improve the grantees' processes, reach, connections, or knowledge in their field. Second, all applying organizations receive mentoring through guidance on project design, implementation, evaluation, and reporting.

COMMUNITY DEVELOPMENT FUNDS (CDF)



FPM continues to operate as a **key regional entity** in its support for and collaboration with other nonprofits and grassroots goups in the region of the Bay of Banderas, both in Nayarit and Jalisco. In 2018, 13 organizations had active Community Development Funds (CDFs) and were able to mobilize a total of **\$ 2,110,110 pesos** in donations from Mexico, the U.S. and Canada through the Foundation to other organizations and projects. In addition to mobilizing funds the Foundation provides CDF holders a number of services, including the payment of invoices, financial administration of projects, monthly reports, mentoring and capacity training.



INDEPENDENT AUDITORS'S REPORT

TO THE BOARD OF ADMINISTRATION. FUNDACION PUNTA DE MITA, A.C.

Point of view

The audit for **Fundación Punta de Mita, A.C.,** has been completed. They involve the financial statements, cash flow, with the explanatory notes. As well as the summary of significant accounting policies within the fiscal year that ended on December 31st, 2018 and 2017.

Fundación Punta de Mita, A.C., financial statements present its financial status and cash flow according with the NIF (Normas de Información Financieras Mexicanas) (Mexican Financial Information Standards) within the fiscal year that ended on December 31st, 2018 and 2017.

Basis of Opinion

The audit has been completed according with the NIA (Normas Internacionales de Auditoría) (International Standards on Auditing) and our responsibilities pursuant to the NIA will be explained later on in the "Auditor responsibilities in relation to the audit of the financial statements" section of our report. Even though we don't belong to the Association pursuant to the Ethics Professional Code of the Mexican Institute of Public Accountants C. A., and we have complied with the other ethical responsibilities pursuant to that code. We believe that the audit evidence we have obtained gives us a sufficient and adequate basis for that opinion.

The Administration of the Association, and the entity Heads of Government responsibilities to the financial statements.

The Administration of the Association is responsible of the preparation and presentation of the presented financial statements based on the NIF. And it is considered for the review of those financial statements for them to be free of fraud or error.

Within that preparation of the financial statements, the Administration is also responsible of the evaluation of the Association to continue to work as an independent business using the very own business Countable principals by reviewing they match with the actual business. Finding a better use for the Association or closing it for good.

The Entity Heads of Government are responsible of the supervision of the financial information procedures of the Association.

Auditor responsibilities in relation to the audit of the financial statements

Our goal is to get a financial statement "Reasonable Safety" which proves that those financial statements are free of physical misstatements because of fraud or error. We also provide an audit report with our point of view. "Reasonable Safety" closes a high level of security but it won't always warrantee a free physical misstatements audit based on NIA regulations when exists.

These misstatements could be for fraud or error, and they become physical if they are seen individually or by addition in the economic decisions of the users within their financial statements.

Our professional judgment remains objective through our NIA's audit. We also study and identify material deviations in the financial statements because of fraud or error. Provide enough and accurate evidence of our point of view by designing and applying new audit procedures.

The risk of not finding a physical misstatement because of fraud is higher than not finding one because of error, for the one for fraud could be for different reasons such as collusion, counterfeit, deliberate omissions, wrong data intentionally given or intern control elusion.

That is why we collect as much information as we can get of the Association in order to design and create audit accurate procedures to evaluate their circumstances not the efficiency of it. And our conclusion is based on if the Administration finances are proper used according to the business. We also point out if there is the existence of a physical misstatement related with facts of conditions of it to be able to continue working or definitely close. If we ever report a physical misstatement, we have to point it out in the audit according to the financial statements within the dates given.

In conclusion we evaluate the financial statements presentation, structure and content, if the information given is accurate with the transactions and underlying facts to accomplish a reasonable presentation. And, at the end we provide the results to the Entity heads of Government including the date of the audit, significant audit findings and report if there is any deficiency within the internal monitoring within the time of the audit.
